PRESIDENT'S MESSAGE



Early this year I was inspired by the voices of two people. They both spoke about our JA heritage and preserving it.

Tamlyn Tomita was the emcee at the SFV JACC's 60th Anniversary Luncheon. The event acknowledged and celebrated the founders of the Community Center and the organizations and members that made it what it is today. Tamlyn is a Valley girl. It was her knowledge and passion about the Center and JA history that stood out that day for me. She expressed how important it was for everyone to share their stories of what it was like growing up and surviving during a time no one could speak up or speak out. The stories of our JA Community cannot be found in text books. Those untold survival stories and experiences that our ancestors held onto *shaped our family*. To hear them now will help us understand why and who we are today. Tamlyn's passion carried forward into everyone's heart that afternoon and re-motivated me to act on her words.

Reverend *Duncan* Ryūken *Williams* was our guest speaker at this year's SFVJACL installation Luncheon. I first saw Rev. Williams in a YouTube video. He and several other Buddhist priests all flew to Fort Sills, Oklahoma to protest the use of Fort Sills as a detention center for the migrant children separated from their parents. As our guest speaker he spoke about his research and discoveries. His research revealed Buddhist priest were immediately picked up by the FBI after December 7th. However, Japanese Christian Clergy were not. He uncovered and shared with us unknown facts and family stories I was hearing for the first time. Stories that again shaped my family's history so I may understand what they went through and why I was raised the way I was.

Motivated, I mapped out a plan. I will begin (again) the JA Heritage Preservation Project. It will begin in the spring. Once a week I will provide workshops on the "how to and what to do". We will record, document and archive our JA history. We will learn how to: research using the internet, libraries and archives; how to develop questions for interviews; how to conduct an interview; scan photos & documents; scholars will provide historical facts; instructors will teach video equipment use, audio set up, lighting, staging; video editing and archiving.

I will be reaching out to all of you for stories, photos, students, trainers, volunteers and general support.

The San Fernando Valley Japanese American Citizens League celebrated New Years on Sunday, January 19, 2020, by installing the Board at the Knollwood Country Club in Granada Hills, California. **Dennis Okita** exchanged his treasurer's hat for the master of ceremonies hat with his dry, well prepared monologues.

Guest speaker **Reverend Duncan Ryuken Williams** who has launched an impressive multi-city book tour for "*American Sutra*," made time to visit our chapter for this event. His message included Tsuru for Solidarity where he influenced 25 Buddhist leaders and 5 members of Tsuru for Solidarity to come to Fort Sill, OK, on July 20. He said, "I was able to join this gathering alongside our friends from many communities including the Japanese American group Tsuru for Solidarity, Latinx Dreamers, American Indian Movement, and Black Lives Matter at a protest organized by United We Dream. The protest was held here -- where the Trump administration had announced in June that up to 1,400 children, separated from their families, would be moved this summer. This gathering followed an initial June protest in

Dilley, Texas. The collective endeavor of many people led to the administration's announcement a week after the second protest that they would halt this transfer to Fort Sill. One camp closed."

A short time later, they left Coney Island and New York for the West. First, they stopped at Sacramento, then Van Nuys and finally Granada Hills where John worked at Rocketdyne as an engineer.

She also worked in the Reading Labs at both Tulsa Elementary School then at El Oro Way Elementary School. 

DAY OF REMEMBRANCE

Saturday, February 15, 2020 at 2PM at the Japanese American National Museum Our Democracy in Crisis: 1942-2000

February 19th is a significant date for the Japanese American community. On this day in 1942, President Franklin D. Roosevelt signed Executive Order 9066, which gave the U.S. Army the authority to remove civilians from the military zones established in Washington, Oregon, and California during WWII This led to the forced removal and incarceration of some 120,000 Americans of Japanese ancestry living on the West Coast, who had to abandon their jobs, their homes, and



their lives to be sent to one of ten concentration camps scattered in desolate, remote regions of the country. Every February, the Japanese American community commemorates Executive Order 9066 as a reminder of the impact the incarceration experience has had on our families, our community and our country. It is an opportunity to educate others on the fragility of civil liberties in times of crisis, and the importance of remaining vigilant in protecting the rights and freedoms of all. We hope to see our SFVJACL members at this event this year.
